Your firm is hereby invited to submit to the City of Atlanta, Department of Procurement (“DOP”), a bid for **FC-8162, Installation, Relocation, Removal, and Repair of Traffic Signals**. The City of Atlanta (“City”) is soliciting bids from qualified parties to provide professional services to install, relocate, remove and/or revise traffic signals, reversible lane signals, street lights and associated hardware throughout the City.

A **Pre-bid Conference** will be held on **Wednesday, April 15, 2015, at 1:00 P.M. EDT**, at 55 Trinity Avenue, Suite 1900, City Hall South, Atlanta, Georgia 30303. The purpose of the Pre-bid Conference is to provide bidders with detailed information regarding the project and to address questions and concerns. There will be representatives from the Department of Public Works, Risk Management, Office of Contract Compliance and the Ethics Office available at the conference to discuss this project and to answer any questions. Bidders are **strongly encouraged** to attend the Pre-bid Conference.

Bidders will be allowed to ask questions during the Pre-bid conference. However, please note that oral answers to questions during the Pre-bid conference are not authoritative. The last date to submit questions in writing is **Friday, April 17, 2015, at 1:00 P.M. EDT**. Questions will be responded to in the form of an addendum.

Your response to this Invitation to Bid (“ITB”) will be received by designated staff of the Department of Procurement at 55 Trinity Avenue, S.W., City Hall South, Suite 1900, Atlanta, Georgia 30303, **no later than 2:00 P.M. EDT, on Monday, May 6, 2015**.

Bids will be publicly opened and read at 2:01 p. m. on the respective due date in Suite 1900, 1st Floor, 55 Trinity Avenue, S.W., City Hall South, Atlanta, Georgia 30303.
