Question 1.

Per the project specification, the City of Atlanta DWM has identified a single subcontractor (Foxboro) for Section 17500 Distributed Control System. The specified contract will constitute a significant portion of the base bid. Please confirm that Office of Contract Compliance goals will be calculated upon the base bid and for the purpose of this solicitation the base bid amount shall not include allowances or Foxboro subcontract.

Answer: Yes. Each proponent must achieve its subcontractor participation featuring Minority and Female Business Enterprises calculated on the base bid amount.

Question 2.

Please confirm that JV is required only if base bid amount is greater than \$5million and for the purpose of this solicitation the base bid amount shall not include allowances nor Foxboro subcontract.

Answer: Pursuant to page 6 of Appendix "A" of the solicitation document, all bidders are required to enter into a joint venture with at least one certified minority and/or female business enterprise. The requirement has been predetermined and is not negotiable.
