ADDENDUM #1**

The following questions and/or clarifications were requested by various Proponents:

1. Question: FC-8762 permits the selling of bottled water, carbonated beverages and chips. The other concession contract inside the Rental Car Center have restrictions places on certain items. Vending machines located in the Rental Car Center sell bottled water, carbonated beverages, bottled juice, chips, mints, and gum. As such, those items were restricted from being sold in the current café concession. Will FC-8762 have the same restrictions placed upon it? Restrictions on bottled water, carbonated beverages, bottled juice, chips, mints and gum.

Response: *There will be no restrictions placed on FC-8762, Branded Sandwich Concession at the rental car center.*

2. Question: Vending machines sell bottled water, carbonated beverages, bottled juice, chips, mints, and gum. Those items were prohibited from being sold in the café concession contract. As sandwiches were part of the café concession contract, will certain sandwich items be prohibited from being sold in the current FC-8762 Branded Sandwich solicitation ? If so, which sandwich items will be restriction?

Response: *There will be no restrictions placed on FC-8762 at this time, Branded Sandwich Concession at the rental car center.*

3. Question: If not, what is the City of Atlanta's justification for not restricting those items when they are restricted for another concession contract?

Response: *This question is relating to another City of Atlanta's Contract and is not related to FC-8762.*
