Your firm is hereby invited to submit to the City of Atlanta (the "City"), Department of Procurement (the "DOP"), a Bid for **FC-10177, Martin Luther King Jr. Drive Corridor Improvements – Fulton Industrial Blvd./SR 70 to Ollie St.** The City's DOP, on behalf of the Department of Public Works (DPW) is seeking bids from qualified firms for construction on a project for 6.2 miles (from Fulton Industrial Blvd to Ollie St.) corridor improvement project, multi-use trails, pedestrian crosswalks, traffic signals, pedestrian and street lighting, bus shelters, raised medians and landscaping improvements at various locations. The existing roadway will be resurfaced and striped to provide one vehicle and one bike lane in each direction and center two-way left turn from Ralph David Abernathy Blvd to Ollie St.

A **Pre-Bid Conference** will be held on **Tuesday, November 21, 2017, at 10:00 A.M. EST**, at the DOP's Conference Room in Suite 1900. The purpose of the Pre-Bid Conference is to provide bidders with detailed information regarding the project and to address questions and concerns. There will be representatives from the DPW, the Office of Contract Compliance, the Ethics Office and the Atlanta Workforce Development Agency available at the conference to discuss this project and to answer any questions.
