A **Pre-Bid Conference** will be held on **Thursday, March 22, 2018 at 11:00 A.M. EDT**, at the Committee Room No. 2 located on the second (2<sup>nd</sup>) floor of City Hall. The purpose of the Pre-Bid Conference is to provide proponents with detailed information regarding the project and to address questions and concerns. There will be representatives from the APD, OEAM, the Office of Contract Compliance, the Ethics Office and the Atlanta Workforce Development Agency available at the conference to discuss this project and to answer any questions. A site tour is scheduled immediately following the Pre-Bid Conference on Thursday, March 22, 2018 at 2375 Metropolitan Pkwy, SW, Atlanta, Georgia 30315. Bidders attending the tour will be required to sign a release form for the Site Visit. Further details regarding the Site Visit will be provided at the Pre-Bid Conference. Bidders are urged to attend the Pre-Bid Conference.

Bidders will be allowed to ask questions during the Pre-Bid Conference.
